

NOTICE OF PROPOSED CLASS ACTION SETTLEMENT

TO: All hourly employees of Wrigley Rooftop Club, Sheffield Baseball Club and/or Ivy League Club ("Defendants") during the period March 31, 2008 through October 3, 2012. On October 3, 2012 a class action lawsuit was filed in the Circuit Court of Cook County entitled *Danhka, et al. v. Wrigley Rooftops III, LLC., et al.*, Case No. 12 CH 37196. The Court has preliminarily approved a settlement and has appointed the law firm of Krislov & Associates, Ltd. as counsel for the class ("Class Counsel"). **THE PROPOSED SETTLEMENT AND ELIGIBLE RECIPIENTS** Class Members who worked at least 7.5 hours any day in calendar year 2012 and were subject to a lunch break deduction that day shall receive a cash payment for all such lunch break deductions plus 2% interest calculated from the day of the deduction through February 3, 2013. Hourly employees who worked 35 or more hours in any week during 2010 or 2011 shall receive a pro rata share of a fund established to pay such claims. Hourly employees other than managers, sales and administrative employees in 2008 to 2012 shall receive a pro rata share of a fund established to pay gratuity claims. Withholding taxes will be deducted from all Class Member payments. **Unless you exclude yourself from the settlement, you will be part of the Class and bound by the Settlement.** Regardless of whether you submit a Claim Form, if you stay in the Class you will release the Defendants from all wage payment claims that you may have during the class period. **THE FAIRNESS HEARING:** A hearing will be held by the Court to consider the fairness of the proposed settlement and to decide whether to issue a final approval of the settlement. The hearing will take place before the **Honorable Judge Neil Cohen on July 29, 2014 at 9:30am in Room 2308 of the Richard J. Daley Center, Chicago, IL 60602.** You are not obligated to attend this hearing but may do so if you plan to object to the settlement. **WHAT TO DO IF YOU WISH TO RECEIVE MONEY OR BE EXCLUDED FROM THE SETTLEMENT, OR OBJECT TO THE SETTLEMENT:** If you wish to obtain the benefits of the Settlement, you must submit a completed claim form by U.S. Mail, **no later than July 16, 2014** to Class Counsel. Objections and requests for exclusion are also due by **July 16, 2014.** **ADDITIONAL INFORMATION:** The description of the case in this Notice is general and does not cover all of the issues and proceedings thus far.
